TRANSPORTATION SIGN-UP FORM 2010-11

(Please fill out a separate form for each student)

We realize that your child's transportation needs may change throughout the year. As such, we offer three payment options. Payment is due within 30 days of billing.

Option One:

Morning and afternoon Dismissal Bus for the entire school year. You agree to pay \$2,500 billable in November. No credit or adjustment can be made for unused days. A 20% discount is offered to second, third and fourth children.

Option Two:

Morning and afternoon Dismissal Bus per trimester. You agree to pay \$940 per trimester, to be billed three times per year (November, February, April). No credit or adjustment can be made for unused days. A 20% discount is offered to second, third and fourth children.

Option Three:

One way, per trip charge, using morning or afternoon dismissal. You agree to pay \$9.60 per one-way trip morning or afternoon dismissal to be billed each month (based upon attendance to be submitted by the bus driver).

You may alternate between options two and three depending upon your child's schedule per trimester. For example, you may want to be billed \$9.60 per trip for actual usage for the 1st trimester but pay the flat fee of \$940 for the 2nd trimester.

Any time the Late Bus is used, a \$15.85 fee will be charged, in addition to your yearly, trimester, or one-way fare billing.
